WHAT IS MEDICAL CODING?

Medical coding is the process of transforming the diagnosis, procedures, medical services, and equipment into universal medical alphanumeric codes. The diagnoses and procedure data are taken from medical record documentation, such as transcription of physician's notes, laboratory and radiologic results, etc. Medical coding professionals help ensure the codes are applied correctly during the medical billing process, which includes abstracting the information from documentation, assigning the appropriate codes, and creating a claim to be paid by insurance carriers.

MEDICAL CODING AS A CAREER:

Because of the high demand for coders, wages for new medical coders grow year after year. The latest reports from the Bureau of Labor Statistics shows that, on average, a medical coder makes \$16.42 an hour for an annual salary of \$34,160, with variations based on location. The top ten percent of earners brought home make more than \$56,000 each year, while the bottom ten percent made slightly more than \$22,000.

Medical coders not only make more money on average, but they work in a professional office setting with gener-ous benefits packages, especially if they work for a large health clinic or hospital.

On the other hand, the only way to get a top tier job is through the completion of a certificate training program.
